Mr. Gorton stated that the request for proposals was advertised and four proposals were received back, including Gila (MSB), Sturgis, CSG Forte and FiNet Paya. Mr. Gorton noted that Treasurer Hitchcock had submitted a recommendation, however it is up to the Commissioners to decide. Currently the providers being used are MSB, Forte and Sturgis. The Commissioners contracted with MSB and signed a four-month extension to get through this process. Mr. Gorton noted that they all had plus and minuses about their proposals, and utilizing the three companies gives multiple options for the departments that handle credit card processing services. Commissioner Lennon inquired about Mr. Hitchcock's letter, to which Mr. Gorton responded in that Mr. Hitchcock recommends the Board contract with Sturgis to provide processing for the County that elects to join. Mr. Gorton stated that every department that signed on to the original resolution needs to confirm in writing that they are joining us for processing.
