

h shall be available at the times and places established by Dr. Lovinger for purposes of the evaluation. The evaluation shall be performed in the safest setting available.

- b) Dr. Lovinger shall have access to all relevant private and public records related to _____, including mental health and competency evaluations and reports conducted in prior delinquency or abuse, neglect or dependency proceedings, if any.
