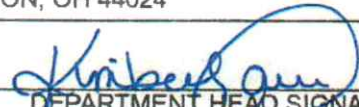

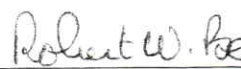
) PROPER ADMINISTRATIVE ORDER
