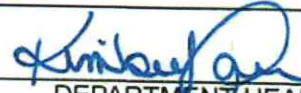

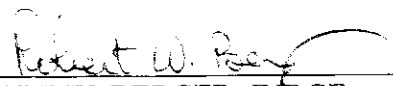
) **PROPER ADMINISTRATIVE ORDER**

Pursuant to R.C. 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$2,025.00 (Two Thousand Twenty Five Dollars and No Cents) from 1001-008-00-601 payable to IBOLD & OBRIEN, for guardianship fees for 23PG378, which the Probate Court has determined to be an expenditure for a proper public purpose. **Kindly provide this Court with the original check which it will mail to the vendor.**

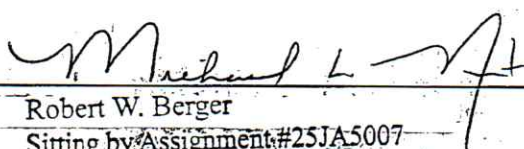

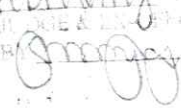
